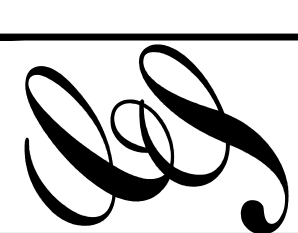


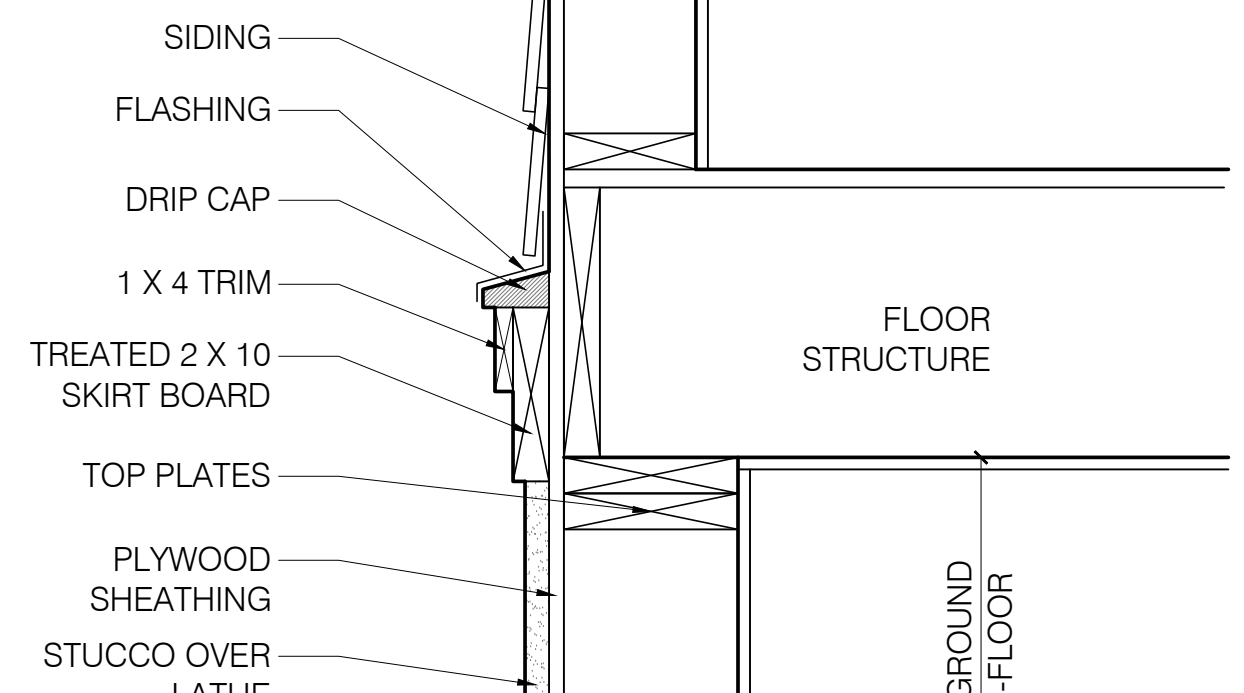

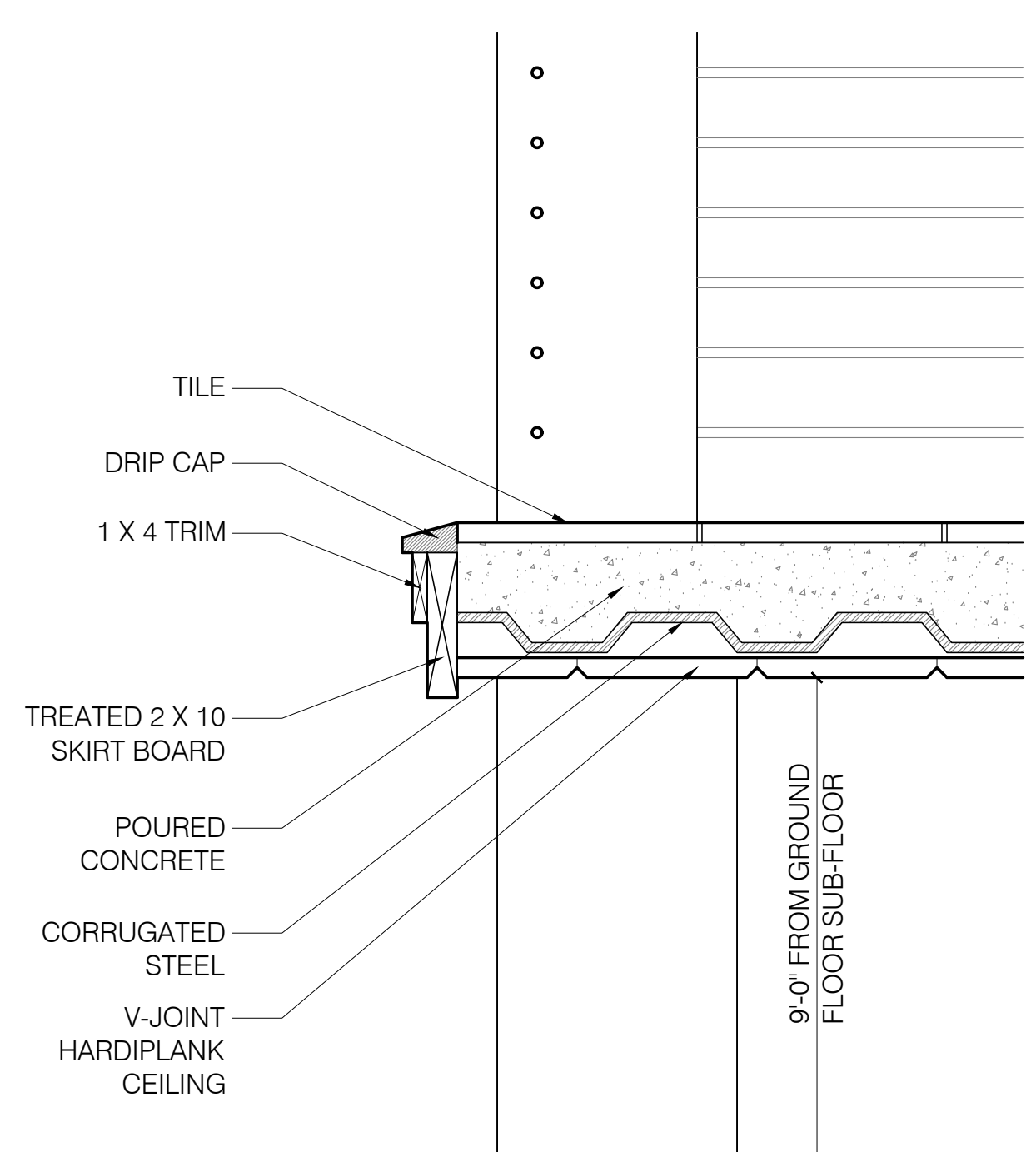

1-1/2" = 1'-0"

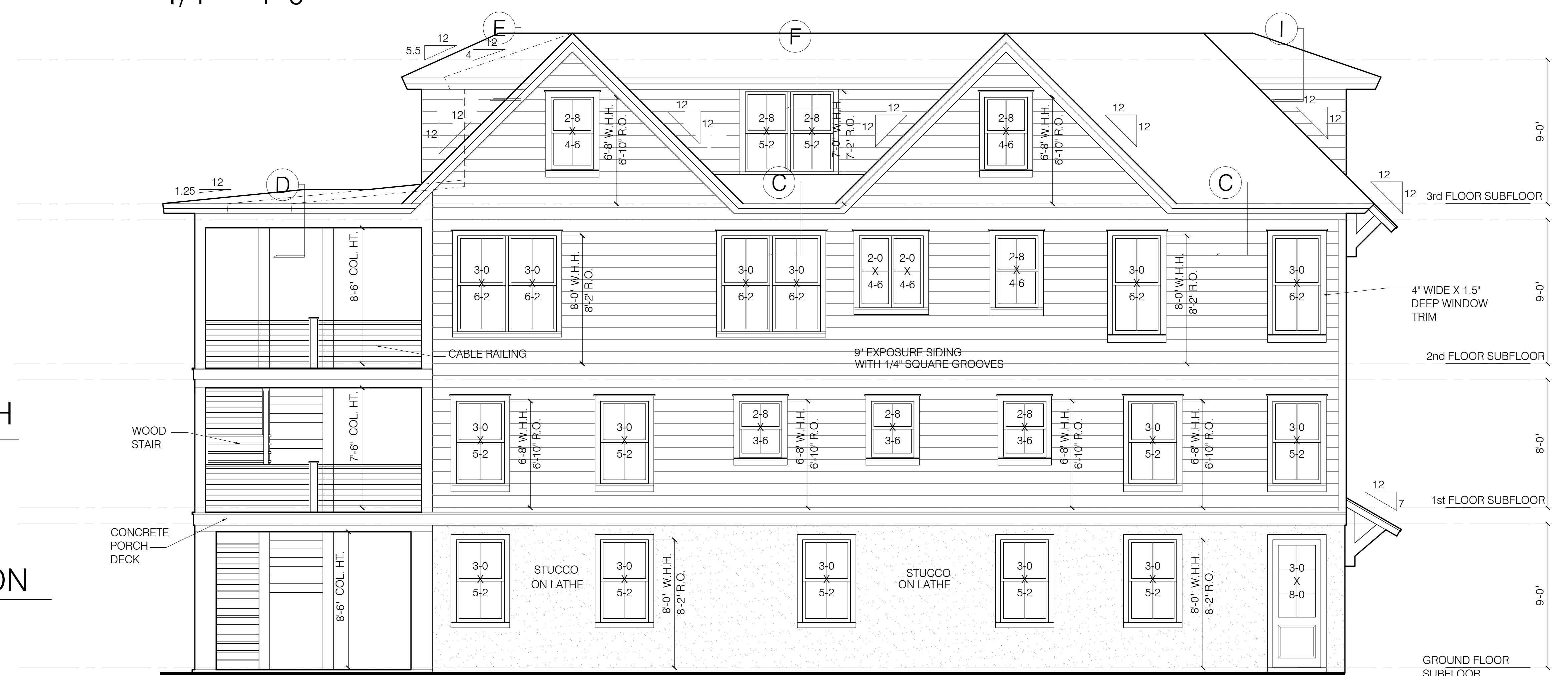
RIGHT SIDE ELEVATION

1/4" = 1'-0"

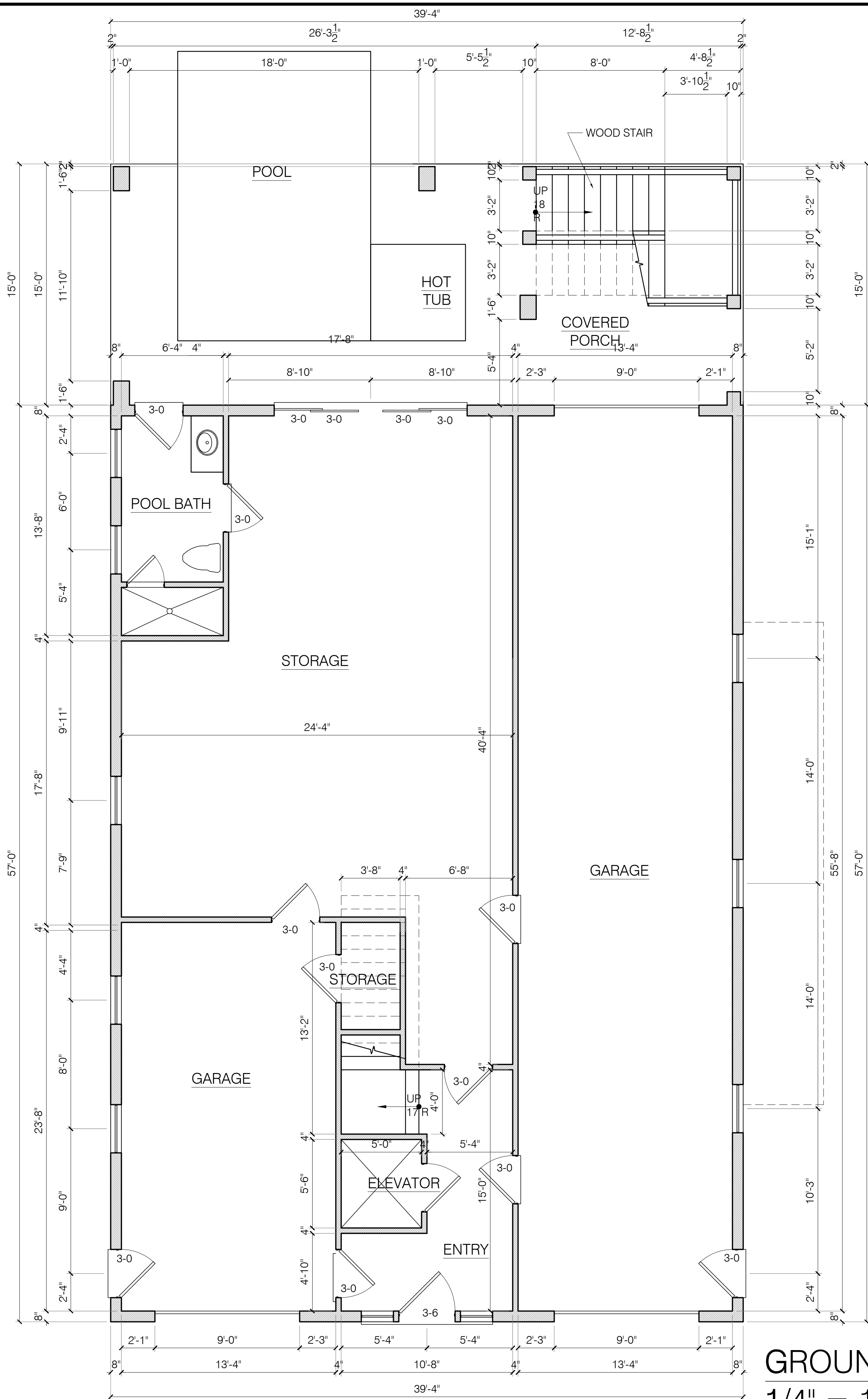


LEFT SIDE ELEVATION

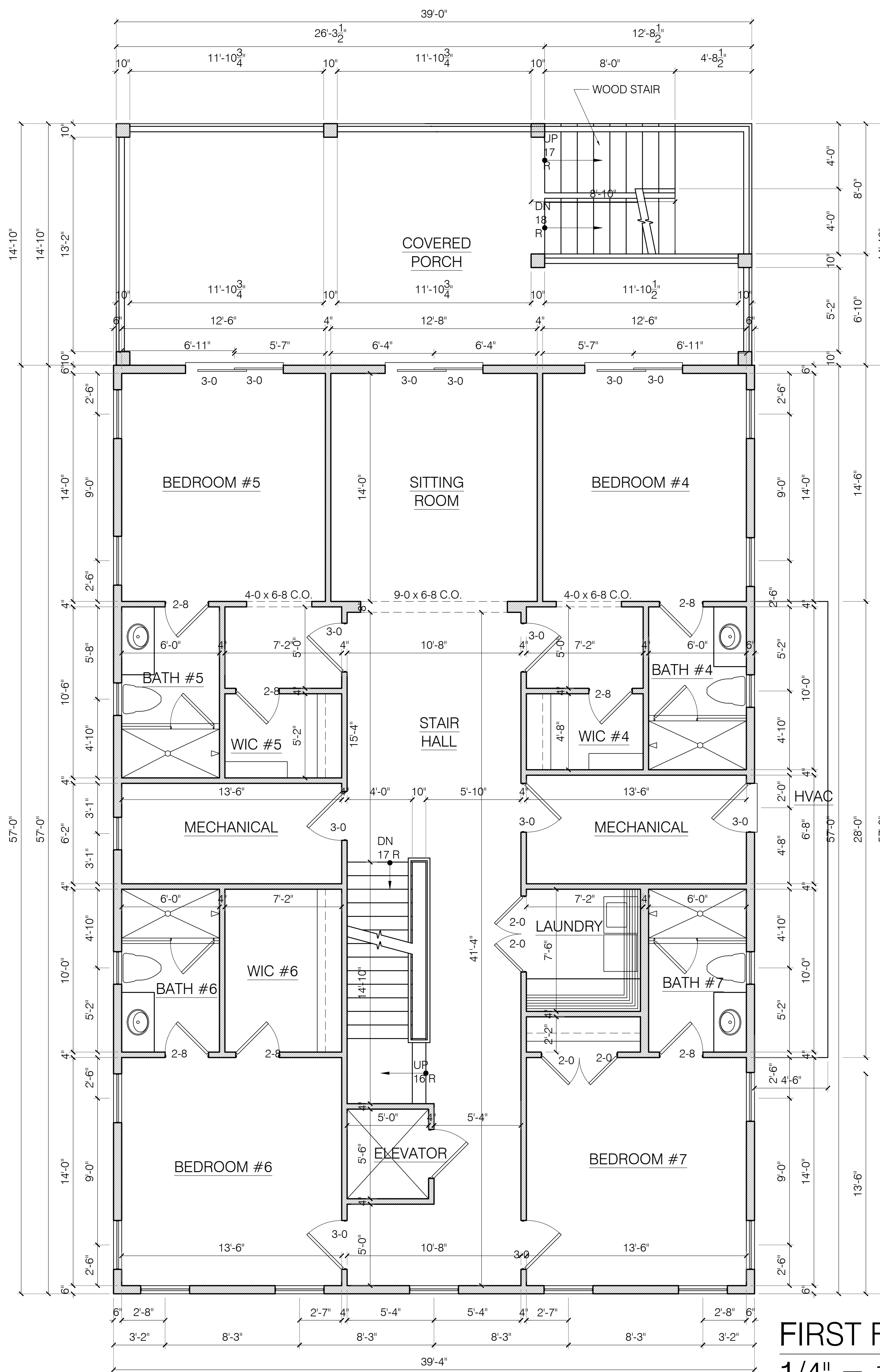

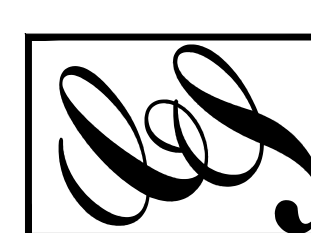

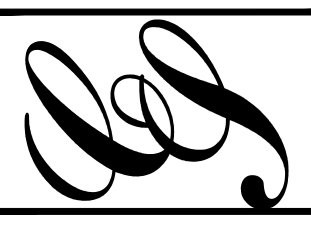
